Applicant should have a GPA of 2.5 or higher. The applicant's most recent official school transcript must accompany the application. A copy of a school transcript will not be accepted without an official school seal. Applicant must have a strong interest in agriculture. Applicant must be a BCA member or be related to a BCA member. All elements of application must be complete.

Amount Awarded: Two \$1000 scholarships will be awarded. One will be given to a graduating high school senior, and one will be awarded to a student currently enrolled in undergraduate coursework. A check will be issued directly to the selected university on behalf of the student.




